## Minutes for Walnut Creek SUD Board of Directors Regular Meeting April 21, 2025

The meeting was called to order by Mike Gilley, at 4:00 P.M. noting the agenda was posted in accordance with Chapter 551, Texas Local Government Code. Quorum was established. The meeting was held at the District's office located at 1155 W Highway 199 Springtown, Texas. The invocation was given by Mark Green. The Pledge of Allegiance was led by Jim Cox.

**Open Forum** – Jolee Skinner was introduced as the new reporter for the Springtown Epigraph. She will be covering future meetings.

**Consent Agenda** – Mark Green moved to approve the Consent Agenda as presented. Seconded by Bill Roesicke. Motion carried 5-0.

#### **General Session:**

- A. Consideration and/or action to call a Special Meeting in May for election canvassing. Jim Cox moved to change the regular meeting scheduled for Monday, May 19, 2025, to Wednesday, May 14, 2025, to meet the canvass deadline. Seconded by Mike Gilley. Motion carried 5-0.
- B. Consideration and/or action to accept the Annual Audit report. Kyle Caperton with MCPA, PC, went over the FY 2024 Audit Report stating that it was a very good audit. He had no issues to report. Jim Cox moved to accept the FY 2024 Audit report as presented. Seconded by Mark Green. Motion carried 5-0.

- 2. 2 MG Ground Storage Tank at Plant Site Contract Amount = \$2,549,400.00 Status: 90% complete
- 3. 0.5 MG Ground Storage Tank Rehab at Plant Site Contract Amount = \$568,607.00 Status: Project Complete
- 4. FM 920 Booster Pump Station Expansion Contract Amount = \$2,774,500.00 Status: 60% complete
- 5. 1 MG Ground Storage Tank at FM 920 Booster Pump Station Contract Amount = \$1,544,000.00 Status: 90% complete

- 7. 0.5 MG Ground Storage Tank at FM 51 Booster Pump Station Contract Amount = \$1,292,400.00 Status: 90% complete
- 8. 0.5 MG Elevated Storage Tank at Thomas Rd. and Johnnie Dr. Contract Amount = \$2,163,000.00 Status: 60% complete
- 9. Water Line Between Keeter Elevated Tank and Jaybird Booster Station Contract Amount = \$7,199,912.79 Status: 80% complete
- 10. FM 51 16" and 12" Water Lines Contract Amount = \$2,053,302.90 Status: 10% complete

Projects in Design Phase:

- 1. 1.5 MG Ground Storage Tank Partition Curtain Plans are complete for this project. This project bidding and construction Fall/Winter months when water demand is lowest.
- 2. FM 51 Elevated Storage Tank

The 1 acre site for this tank has been purchased. The plans for the tank have been revised based on the new site and are in the final completion stage. We will advertise this project for bid beginning on May 1, 2025 and open bids on May 15, 2025.

### Monthly Engineer's Report Walnut Creek Special Utility District Up-Date Report On All Current Projects

- 3. 20" Water Line From FM 920 Booster Pump to Agnes Elevated Storage Tank Survey work is done. Construction plans are being finalized and this project should be ready to bid by May 1, 2025.
- 4. Three Skillet Rd., Roads Ln & Shady Ln. 12", 8" & 6" Water Lines The completion of this project has been put on hold for now. We would like to see how much of the bond funds remain after bidding the FM 51 Elevated Tank and the 20" Water Line From FM 920 Booster Pump to Agnes Elevated Storage Tank. After that we can evaluate the project and see if there needs to be any changes to the scope of the proposed project.

#### II. Private Developments

1. We are currently working on and have complete numerous feasibility reports for new developments within the district. We are also working with the engineers for Paradise ISD to assist them with the water needs for the new Paradise High School.

# **General Managers Report**

 Construction on the following projects, from the bond, are underway in some form: -

- 1,000,000 gallon ground storage tank on F.M.920. This tank is complete and painting is underway. Tie in for 12" was done on 3/11/25. Options for the 16" tie in are being explored so as to not shut off water to Poolville.

- 2,000,000 gallon ground storage tank at the water plant. The tank is complete and awaiting tie in so that disinfection can be completed.

- 2, 2 million gallons a day filters at the water plant. Construction has started.

- Booster plant expansion F.M.920 ties in with 1,000,000 gallon tank at this location and is nearing completion. See 1,000,000 Ground storage tank above.

- South F.M. 51 booster pump station. 80% complete

\_500,000 gallon storage tank south F.M. 51. Construction is near complete on tank piping is still being installed and the tank is still awaiting paint crew.

- Major water line upgrade from Keeter Rd to Jaybird lane consisting of: 27,504' of 16" water line

18,273' of 12" water line

2,052' of 8" water line. This project is 70% complete. Project is near 80% complete

\_500,000 gallon elevated tank Thomas Rd. Ready for paint

\_ Construction has begun on the Water line project along South FM 51 and crossing the Olmstead property. 35% complete

• Construction projects that have been completed from the bond

- Emergency 16" water line upgrade from Jaybird Lane to Veal Station Rd.

\_ Upgrade of 300,000 gallon elevated storage tank ( Partagas Tank) raising the tank 58' higher

- Emergency repairs to 500,000 gallon clear well at water plant

Bids will be taken soon for the 500'000 gallon elevated storage Tank to be built South of Veal Station Rd on Melvin Woody's property. The purchase of the property was completed 1/28/25. Preliminary work has begun.

> (•) 31 new meters have been set, 51 meters changed out and 34 MIU units have been set since last month's meeting. For the year thus far 169 meters have been changed out, 118 new meters have been set.

- 393 work orders were completed from 3/17 thru 4/15
- There have been 3 boil water notices since February's meeting. See attached

Emergency generator installation is underway at the water plant, Jaybird lane pump station and 2123 pump station. These meet TCEQ Emergency Preparedness Plan standards. The Generator for the 920 pump station is still on backorder. These Generators were ordered in March of 2024.

The next meeting of the Wise Regional Water District will be on 4/23/25 Perry Day and myself will be attending to follow progress reports. Walnut Creek SUD is now a member and will have a seat on the Board of Directors.
